## Corporate liveryman raises £33,000 in Everest attempt

Damian Walters, chief executive of the British Institute of Kitchen, Bedroom & Bathroom Installation (BiKBBI) and a corporate liveryman of The Furniture Makers' Company, has raised a huge £33,000 for our charity through his attempted climb of Mount Everest.

Damian set off on his journey on Saturday 8 April, but was forced to abandon his climb at 28,300 feet, 700 feet from the top, when life threatening winds and stormy weather conditions made it too treacherous for the expedition to continue.

In his pursuit for the summit, Damian endured a two month trip that included extreme weather, severe altitude sickness, a two stone weight loss and conditions that prevented many climbers from reaching the top or some from coming back down.

Damian self-funded his trip but has raised £33,000 for us through corporate sponsorship and donations from the industry, friends and family.

Damian said: "The past two months on Everest was harder than I could ever imagine, but an incredible expedition

nevertheless. I'm immensely proud of reaching the point I did and I see it as a great personal victory.

"It is easy once you're up there for climbers to succumb to a 'summiting at any cost' mentality, but returning home from the mountain is more important to me and of course my family.

"I want to thank the sponsors, particularly my main sponsor Classic Marble, for helping me to raise £33,000 for such a worthy cause that's close to my heart."

# Message from Jonny Westbrooke, CEO

#### How we help

Our charity was set up over 100 years ago to help people from the furnishing industry in times of hardship.

We are here to help anyone from our industry when times are tough with one-off grants, services, time and support.

Your support helps our charity and ensures we will always be here to assist people like Gerald, Elaine and Ann.

Gerald, a retired woodworking machinist for Shapland & Petter Furniture Makers, is unable to walk down to the local shops or go for a drink in the pub because of deteriorating medical conditions that affect his mobility.

The lack of contact with the outside world was leaving him feeling socially isolated.

He managed to save up for a mobility scooter, but discovered that he wouldn't be able to use it because the pavement outside his home is too narrow, and he risked tipping off the edge of the kerb.

Being resourceful, he found a ramp with the idea of driving into the road, but he was unable to manoeuvre it into place.

The only solution left for Gerald was to have the kerb dropped.

However the cost of this was more than he could manage, at nearly £1,400.

Having worked in the furniture industry for more than 20 years, Gerald applied for one of our welfare grants.

We were delighted to pay for the kerb to be dropped, just in time for the spring.

Gerald has since been able to get out and about and feel part of his community again.

Elaine fell into rental arrears after suffering a serious heart attack that forced her to give up her job as a carpet winder.

She soon began to struggle without her earnings as her housing benefit didn't cover the rent. Worse still, when Elaine applied for support from her local authority she discovered that her flat was affected by the 'Bedroom Tax'.

She was eventually re-housed to an affordable, one bedroom flat, but it had bare floors. With no money to buy carpet, the stress of debt and the effects of living in a cold flat was making Elaine's health even worse.

Fortunately, a local welfare agency pointed Elaine in our direction and supported her to complete an application for a welfare grant.

We were able to clear her rent arrears and pay for carpets to be fitted before winter. Elaine said she was "over the moon" at the generosity she received and is loving how cosy her flat now is with the carpets.

Ann's husband Ron spent his entire career working for Utility Furnishings in Edmonton. Deaf since the age of seven following meningitis, Ron went to a special school where woodwork was his passion. He began work with the company as soon as he left school.

The couple met when Ann was only 15, getting engaged when she reached 16. She was able to help Ron communicate, telling him what people were saying and helping him to follow the plot when they went to see a film.

When Ron's health began to deteriorate and he could no longer work, our charity was able to help with a small regular grant which was a huge relief to the couple. Sadly, after several operations, Ron passed away but Ann was relieved to know that our support would

continue, especially as her own health was beginning to deteriorate. She now has curvature of the spine and with our help, she was able to buy an adjustable bed so she can have a good night's rest.

Although housebound and in chronic pain, Ann keeps cheerful with the help of her faithful companion, cat Tiddles, and loving and supportive family and friends.

"I like to remember every day all the ways in which I am lucky," she says. "Having The Furniture Makers' Company as one of my friends means a lot to me."
