## **Executive summary**

This digest is an essential read for anyone operating in the furniture sector and is a distillation of information that is primarily sourced from the websites of government bodies such as the Office for National Statistics (ONS), HM Revenue and Customs, Communities and Local Government and Bank of England. The available data (covering the period 2018 to 2022 (where data is available), has been analysed and compiled to produce the following series of reports:

- 1. Consumer spend
- 2. The structure of the UK furniture manufacturing industry, its size, distribution and number of employees
- 3. Furniture manufacturers turnover, imports and exports
- 4. The total size of the furniture industry, including manufacturing, retailing, distribution and repair
- 5. Trading relationships with the rest of the world and an analysis of trade gaps

All data sources are referenced within the report and are publicly available to organisations wishing to undertake their own statistical analyses.

The industry structure figures cover furniture manufacturing as a whole and, in addition, data is presented for the following sub-sectors:

- 1. Office and shop furniture
- 2. Kitchen furniture
- 3. Mattresses
- 4. Other furniture

Turnover, import and export data are presented for the above sub-sectors. It has also been possible to analyse each of these sub-sectors in more depth. As such, trade figures are shown for a range of contract, office and domestic product groups.

A brief commentary, largely focussing on medium-term trends and the changes between 2018 is 2022, supports the tabulated and graphical data and includes highlights such as:

#### The UK furniture and furnishings sector

- The UK furniture and furnishings sector, comprising design, manufacturing, retail and repair is much larger than many people think.
- Total manufacturing turnover for this sector in 2022 was £11.35 billion, representing a year-on-year increase of 9.2%.
- This turnover emanated from 6,880 companies employing 91,000 individuals.

 The wider sector, including specialist retail but excluding general retail, comprised over 29,932 VAT registered companies supporting in the order of 292,000 jobs, with a combined turnover of £41 billion.

#### Consumer spend

- Total UK consumer expenditure increased between 2021 and 2022 to £1,352 billion (an increase of 5%, following a decrease in 2020 of 13%).
- Despite this increase in total spending, expenditure for the wider furnishings, household goods and routine maintenance sector fell by 5%.
- Consumer expenditure on furniture & furnishings was just over £20.1 billion in 2022.

#### Furniture industry trends

- Total manufacturing turnover in 2022 was £11.35 billion, which was 10% higher than 2021.
- In 2021, 6,857 UK furniture manufacturers employed a total of 90.000 individuals.
- Office and shop furniture saw turnover increase to £2.37 billion in 2022.
- Turnover in the "kitchen" sector showed an increase in 2022 to £3.84 billion.
- The "mattress" sub-sector grew slightly to £0.9 billion in 2022.
- The rest of furniture manufacturing comes under the heading of "other furniture" and comprises the largest of the industry's four sub-sectors. 2022 turnover was £4.64 billion, an increase on the 2021 figure of 16%.
- "Other furniture" has a significant influence on UK furniture manufacturing's overall performance figures, accounting for 31% of turnover. As such, any recovery in turnover here normally reflects the overall position of the whole furniture sector.
- Furniture manufacturing continues to be dominated by micro and small to medium size businesses with just 305 companies (5%) operating at turnovers in excess of £5 million.
- 150 companies turn over more than £10 million, which is slightly higher than the previous year.
- The latest data indicates 6,880 companies in the sector. Most of this growth has been in the number of companies turning over less than £1 million, although there has been a slight increase in the number of organisations in the £1 million to £5 million bracket as well as the £5 million to £10 million and £10 million to £50 million brackets. This, particularly in the higher turnover brackets, is assumed to be due to growth rather than new entrants.

- 83% of companies turnover less than £1 million and the largest percentage of companies are in the £100,000 to £250,000 turnover band. This is largely unchanged from the previous year.
- There remains a significant proportion of extremely small companies within the whole furniture manufacturing sector with 58.2% of organisations operating at turnovers of less than £250,000.
- In the "mattress" and "office and shop" sectors the percentage of smaller companies is lower than for the other sectors (61.9% and 66.5% within these sectors turnover less than £1 million respectively). Conversely, in the "other furniture" and "kitchen" sectors turnover is significantly higher at 87.1% and 85.8% respectively.
- The "mattress" sector has proportionately more large companies than other sectors, with 16.7% of companies turning over more than £5 million, an increase of 33% from 2016. In comparison, 9.8% of companies within the "office and shop" sector turnover more than £5 million, followed by "kitchen" (3.6%) and "other furniture" (3.1%).

#### International trade

- Imports of furniture into the UK in 2022 increased to £8.5 billion.
- As in previous years, by far the biggest value of imports originated from China (£3.2 billion), with its share of imports into the UK increasing slightly to 38%.
- In purely financial terms Poland ranked second in the hierarchy of furniture exporters to the UK. Germany moved to third position with Italy dropping to fourth. In round terms, these countries accounted for 10%, 9.5% and 9% of furniture imports into the UK respectively at around half a billion pounds each.
- Furniture exports have continued to grow in recent years reaching £1.4 billion in 2022.
- Exports to the Irish Republic continue to grow year on year and reached £0.29 billion in 2020, an increase of 16.2% from 2019.
- There was an increase in UK furniture exports to the USA in 2022 (£252 million) which accounted for 12.3% of the total. And the USA overtook Ireland as the largest export market for the first time.
- The 2022 negative trade gap with China (the largest for the sector) was £3.1 billion There were also large negative trade gaps with Poland, Italy and Germany.
- The main positive trade gap, as in previous years, was with the Irish Republic. This gap, despite the Republic's recent increases in exports to the UK, moved from £0.19 billion to £0.13 billion in 2022.

## 1. Introduction

This Statistics Digest is the Research Association's compilation of published statistics and market information which has been sourced primarily from the Office for National Statistics (ONS), HM Revenue and Customs, Bank of England and the Communities and Local Government websites. It comprises both national economic factors of a general nature (these will have a direct influence on the market demand for furniture) and data specific to the furniture manufacturing industry and its different sectors.

The digest incorporates the latest available statistical information, relating to 2019 and 2023 where available, and for certain criteria, also presents "time series data".

A full list of analyses is summarised on the "Contents" page.

It is important to recognise that all statistics should be treated with caution and are only as good as the raw data from which they are compiled.

Every attempt has been made to utilise standard core sets of data and to adopt a consistent approach. However, data inconsistencies do occur from time to time, and, under these circumstances, the best available figures have been employed.

## 2. Furniture source data

The data and information contained within this digest relate to most furniture items that would normally be found in the home (domestic), office and contract sectors of the UK furniture market.

The majority of furniture statistics are sourced from time series data available online through the Office of National Statistics and by using industry SIC (Standard Industrial Classification of Economic Activities) and CN (Combined Nomenclature) codes.

Specific sources of information for each of the analyses within the report are referenced below the tabulated data. This enables the source data to be readily accessed should individuals, or organisations, wish to carry out more in-depth analyses for themselves.

Traditionally, it has been preferable to differentiate between office, domestic (home) and contract furniture. However, in many cases, these sectors overlap within the classification codes. Every attempt has been made to differentiate between office and domestic sectors, but contract data are inevitably masked within these two sub-sectors.

In addition, some "non-furniture" items tend to be included within national statistics for furniture and equally, items that might readily be described as furniture are often omitted or included within the SIC codes for another industry sector.

# 3. Standard Industrial Classification (SIC)

## 3.1 Introduction

The United Kingdom Standard Industrial Classification of Economic Activities (SIC) is used to classify business establishments and other standard units by the type of economic activity in which they are engaged. It provides a framework for the collection, tabulation, presentation and analysis of data.

UK manufacturing information within this report is compiled using the SIC (07) classification system, which facilitates consistency when comparing statistical data (note that pre-2008 data was compiled using a different set of SIC codes, thus making time series comparisons with such data unreliable).

World trade figures are compiled using the Combined Nomenclature Classification system (CN numbers) as defined within the Official Journal of the European Union, L312. The Combined Nomenclature classification system is slightly different from the SIC (07) system. However, the two systems do cross reference thus facilitating valid comparisons between UK manufacturing, imports and exports.

Full details of the two classification codes, and their comparability, are presented in the subsequent section of this report.

## 3.2 SIC and CN code systems

#### 3100 Manufacture of furniture

This division includes the manufacture of furniture and related products of any material except stone, concrete and ceramic. The processes used in the manufacture of furniture are standard methods of forming materials and assembling components, including cutting, moulding and laminating. The design of the article, for both aesthetic and functional qualities, is an important aspect of the production process. The division is subdivided into the following categories and sub-categories:

## 5.2 Manufacture by product groupings

#### 5.2.1 Introduction

The broad sub-sector groupings within the previous section can be broken down further into different product groupings using the PRODCOM 31 report issued by ONS. It is important to recognise that there are differences between UK production data collated for the Annual Business Survey (Section 5.1) and those collated for the PRODCOM reports referenced in this section. This is attributable to a number of factors such as:

- PRODCOM focuses on products and the Annual Business Survey (ABS) on activities.
- Samples of companies contributing to data differ between the Annual Business Survey and Prodcom.
- Report timing (ABS uses financial year end data and PRODCOM uses calendar year end data).
- Inclusion or exclusion of income derived from non-manufacturing activities within PRODCOM.

# 5.4 Breakdown of the UK furniture industry by turnover, number of employees and by region

#### 5.4.1 Data sources

The total numbers of companies and employees within this section are slightly different from those reported in Section 5.1. This is because data have been collated from a different source (UK Business Activity, Size and Location). In addition, the data is the latest figures available as published in September 2023. However, it remains important to use data from this source so that a breakdown of the comparative sizes and locations of businesses within the furniture sector can be reported.

When analysing these data sets it is important to recognise that the lowest common denominator appears to be 5, which will impact on the significance of results from some of the categories that display lower totals and may also mean that some "totals" in one table differ slightly from "totals" in other tables.

### 5.4.2 Number of furniture manufacturers by turnover band

The industry is dominated by micro and small to medium-sized businesses with just 305 companies (5%) operating at turnovers in excess of  $\pounds$ 5 million (an increase of 5% when compared to the previous year). 160 companies turnover more than  $\pounds$ 10 million which is slightly higher than the previous year.

The latest data indicates 6,880 companies in the sector, a slight increase from last year. Most of this growth has been in the number of companies turning over less than £1 million, although there has been a slight increase in the number of organisations in the £1 million to £5 million bracket as well as the £5 million to £10 million and £10 million to £50 million brackets. This, particularly in the higher turnover brackets, is assumed to be due to growth rather than new entrants.

83% of companies turnover less than £1 million and the largest percentage of companies are in the £100,000 to £250,000 turnover band (31.4%). These figures are largely unchanged from previous years.

In the "mattress" and "office and shop" sectors the percentage of smaller companies is lower than for the other sectors (61.9% and 66.5% within these sectors turnover less than  $\pounds 1$ million respectively). Conversely, in the "other furniture" and "kitchen" sectors it is significantly higher at 87.1% and 85.8% respectively.

The "mattress" sector has proportionately more large companies than the others with 16.7% of companies turning over more than £5 million. In comparison, 10.4% of companies within the "office and shop" sector turnover more than £5 million, followed by "kitchen" (3.6%) and "other furniture" (3.1%) sectors.

There remains a significant proportion of extremely small companies within the whole furniture manufacturing sector with 56% of organisations operating at turnovers of less than £250,000.

### 5.4.3 Number of furniture manufacturers by employment size band

The turnover pattern is to an extent reflected in the employment figures with 79.5% of companies employing less than ten people and only 130 companies (2.0%) employing more than 100.

As expected, this trend is different in the "mattress" sector, with 54.8% of mattress manufacturers employing less than 10 people, whilst 9.5% employing more than 100.

The "office and shop" sector, whilst similar to the other non-mattress sectors at the higher levels of employment, also has fewer companies employing less than 10 people (66.5%), compared with the remaining sectors.

## 5.4.4 Regional distribution of furniture manufacturers

The subsequent table illustrates that furniture manufacturing companies are generally evenly spread around the United Kingdom with no single, significant geographical hub. However, there are some notable exceptions to this broad conclusion.

The North East, Scotland and Wales have significantly fewer furniture manufacturers than other regions (2.7%, 4.0% and 2.8% respectively). Although Wales and the North East have remained quite static in the number of businesses, this has increased for Scotland and the North West. Northern Ireland has seen a slight decrease and accounts for 5.2% of all furniture manufacturers.

The South East has proportionately more companies than any other region (13.4%) and, combined with London, accounts for 24.2% of all UK furniture manufacturers.

38.7% of "office and shop" furniture manufacturers are in London, the South East and the East.

"Mattress" manufacturing is more regionalised than other sub-sectors with 59.5% based in Yorkshire and The Humber, an increase year on year. Conversely, none are recorded in the adjacent North East region or Wales.

Northern Ireland has slightly more "kitchen" manufacturers than most other regions (12.3%), a figure which is closely matched by the South East.

Wales, Scotland and Northern Ireland comprise lower numbers of "other furniture manufacturers", accounting for 10.6% collectively. However, in general, and except for the North East (2.7%) there is a relatively even geographical spread throughout England.

# 6. Furniture markets

## 6.1 Introduction

World trade figures used to be sourced from the ONS but, due to coherence issues associated with the data, they are now extracted from HM Revenue and Customs records (<u>www.uktradeinfo.com</u>). They categorise data product groups using the Combined Nomenclature Classification system as defined within the Official Journal of the European Union, L312.

UK production figures are still sourced via the ONS PRODCOM report. They categorise data using both the SIC Code System and the aforementioned CN classification system.

As such, data from both sources can be cross-referenced (although small errors may accrue due to the coherence issues referred to at the start of this Section) thus enabling estimates of the UK home market to be calculated.

The two coding systems are summarised in Section 3.2 of this report.

It is also important to reinforce (as detailed in Section 5.2.1) that there are differences between UK production data collated for the Annual Business Survey (Section 5.1) and those collated for the production information within this section. Whilst both the Annual Business Survey and PRODCOM collate total turnover, there are distinct differences between the two in that PRODCOM focuses on products and ABS focuses on activities. The total value of production for business in an industry group (PRODCOM) may be different from the turnover reported by ABS for the same industry group as enterprises may carry out other activities, besides production, which contribute to turnover.

## 6.3 Trade by country

#### 6.3.1 Introduction

Data comprises the top importing and exporting countries to and from the UK.

Global regions and other individual country breakdowns are available by interrogation of the uktradeinfo website (<u>www.uktradeinfo.com</u>).

#### 6.3.2 Imports

Imports of furniture into the UK in 2022 were £8.52 billion.

The majority of imports originated from China ( $\pounds$ 3.17 billion), with its share of imports into the UK remaining at 37%.

Italy, Poland and Germany remain the next highest exporters to the UK. In round terms, these countries accounted for a combined 24% of furniture imports into the UK respectively at around £5.5 billion each.

#### 6.3.3 Exports

Furniture exports have continued to grow in recent years and reached £1.46 billion in 2022.

Exports to the Irish Republic continue to grow year on year and reached £0.23 billion in 2022 and the Republic accounts for 17% of all exports, a figure that has remained relatively stable in recent years.

There was an increase in UK furniture exports to the USA in 2022 ( $\pounds$ 0.25 billion) which accounted for 20% of total exports and overtook Ireland to become the largest market for exports.

#### 6.3.4 Trade gaps and trends

Total furniture imports into the UK have increased year on year, with the figure for 2022 being  $\pounds$ 8.5 billion.

China remains by far the largest importer of furniture into the UK. In 2022 imports from China totaled  $\pounds$ 3.17 billion which represents 37% of all imports.
